Directions from Hwy 75:

HWY 75 North to 146th St. N. (Collinsville/Skiatook Exit)

East or right toward Collinsville (146th/ aka hwy 20). Travel about 5 miles until you come to intersection of Hwy 20 & 19th St. (E-Z Mart is on north corner).

Turn left or North continue 1 mile, St. Therese is on the right.

Directions from Hwy 169:

169 North to 146th St. N. aka Main street, Collinsville)

Turn left on Main Street; follow through town, at the end of town the road turns north, you are now on 19th St. Continue north, Church is one mile up on the right.
